In the event that this Guaranty of Payment shall be collected by or through an attorney at law after maturity, Ferebee Corporation shall be entitled to collect from the undersigned all attorney's fees and expenses incurred in the enforcement of the terms and conditions of this agreement.

This obligation shall be construed in accordance with the laws of the State of North Carolina and shall bind heirs, Executors, legal representatives, successors or assigns of the undersigned, and when signed by more than one shall be joint and several obligations of each.

I also agree to pay Ferebee Corporation in accordance with their payment terms of net 15, and understand that a finance charge of 1.5% will be assessed monthly (18% annualized) on all past due balances.
