Interest will be charged on past due accounts at the maximum rate allowed by law. Any accounts with invoices that are approaching 60 days old may be placed on "No Sale" status until invoices are paid. Cash and credit card sales may not be permitted during that time. When payment for invoices on a "No Sale" account is received, it will be 48 hours before the account will be released. Legal action, including the filing of liens, may be taken on accounts 60-90 days or older. If it becomes necessary to initiate collection proceedings, Ferebee Corporation shall be entitled to collect from the undersigned all attorney's fees and expenses incurred in the enforcement of terms and conditions of this agreement.
